#### Milestones in the Translearn project

- Preparation of the Translearn application in 2004-2005, informal acceptance in December 2005, start date April 1, 2006

- Inductive reasoning based on constructed narratives, secondary sources and cross-national comparative surveys
- Involvement of two Steering Committees
- Final report: New Modes of Globalizing: Experimentalist ... Lessons from the Nordic Countries and Slovenia





# Phases of development in the NBS research programme

- Economic actors shaped by national history and evolution of institutional configurations
- Widening scope of interfaces between the national and the global: MNCs, global financial markets, off-shoring of manufacturing operations and services, transnational epistemic communities and regulations, federal features in the EU; impact on the capacities of national champions and space for national policies
- Research based on actor-centred institutionalism:
  - bottom-up initiative of local actors engaged in global business games by using and reconfiguring institutional resources
  - e.g. Kristensen and Zeitlin (2005). Local Players in Global Games. OUP
  - Translearn project: ambition to catalyse a third phase



### "New Modes of Globalizing"

- Peculiarity of the Nordic model Slovenia as a test case
- Interpretations of observations from case studies by relating them to cross-national survey data
- Surprising differences in the dynamics of change of the national business systems and types of dynamic complementarities
- Availability of and need for new risk sharing tools: employees, citizens, entrepreneurs, etc. – Towards an enabling welfare state



### COMPLEMENTARY DIALOGUES AS THE SECOND OBJECTIVE OF THE WORKSHOP

- Contextual change
  - the dynamics of global value chains
  - competition models
  - financial markets
- New actors in global settings: the role of different subsystems
  - labour markets and industrial relations
  - innovation system
  - dynamic recombination of institutions and organising of companies and work,
- Regulations of relations among subunits, role of social movements, etc.



- Inventing new ways to understand the dynamics of change between levels of aggregation, actors, institutions and systems
  - "Revolution" as a routine: Interesting pathbreaking examples?
  - The role of EU and experimentalists forms of governance, social movements, etc.
- Exploring potentials for transnational learning: new types of roles, identities, rules and practices
